



Sub: Inclusion of 18% GST in Affiliation fees and other fees w.e.f. 01.07.2017 to onwards.

Sir/Madam,

I am directed to inform you that as per the letter received from the Additional Director, Directorate General of Goods and Services Tax Intelligence, Bhubaneswar vide No. DGGI/INV/MISC/240/2020-Gr.C-O/o Pr ADG-DGGI-ZU-Bhubaneswar-140897/2020, dated 21.10.2020, the decision of Syndicate in its meeting held on 10.03.2021 and subsequent approval of the Vice-Chancellor on dated 04.05.2021, it has been decided that 18% GST will be collected in the Affiliation fees and other fees from all affiliated/non-affiliated colleges under Utkal University w.e.f. 01.07.2017 onwards.

All the Principals/Directors are requested to pay 18% GST on the Affiliation Fees & Other fees (i.e. Proposal Book Fee, Subject Fee, Academic Fees & Processing fees) which were already paid or to be paid from the academic session 2017-18 onwards in shape of DD/BD/BC in favour of the Comptroller of Finance, Utkal University, payable at SBI, Utkal University Campus Branch, Bhubaneswar along with a detailed statement (year wise) be submitted to the Affiliation Section at the earliest. Henceforth at the time of deposit of Affiliation Fees & other fees, 18% GST may please be included; otherwise the fees will not be accepted.

Further, as per the decision of the Syndicate dated 10.03.2021, 10% of fees has also been enhanced in the existing Affiliation Fees & other fees from the session 2021-22 onwards.

This may please be treated as Most Urgent.
