The Principals of the concerned colleges / Heads / Course Co-coordinators of all the P.G. Departments of Vani Vihar are requested to prepare the list of awardées of Gold Medals of 2021 Examinations pass-out and submit the same to the undersigned by 10.01.2022 positively without further delay for preparation of Gold Medals and follow up action for the 51ST Annual Convocation of the University as per the rule enumerated below:-

1. (A) Gold Medal will be awarded to the candidate placed in the First Class and who has secured the highest mark in a subject amongst Regular (i.e. excluding private candidate) students of the University who has appeared the examination within the normal period as stipulated in the Regulation without any Repeat / Back Paper and who has not been awarded grace mark or has passed the examination under hard case rule with the following clarification those who have not been included under CBCS Course.

(B) That those who appear back paper (s)/ repeat paper (s) or who remain absent or who do not fill up form in the normal schedule or who have secured grace mark or who have passed through hard case rule, they are not eligible for Award of Gold Medals. Gold Medal shall be awarded for each subject every year and only in case of non availability of a First Class candidate as per above rules, Gold Medal for that year need not be awarded.

2. The following Principles shall be adopted for award of the Gold Medal under choice Based credit System (CBCS) as per the proceedings of the Regulation Amending Committee (RAC) held on 20.01.2017 and approved by the Vice-chancellor on 20.01.2017.

The Gold Medal under CBCS Course shall be awarded to the student who has scored the highest CGPA without any re-appearance, including improvement and any absences, in case two or more students score the same CGPA, marks shall be taken into account, here again the above Principle of those with re-appearance including improvement and any absences shall be applicable.

- I. It is further clarified that no student who has secured any grace mark shall be eligible for any Gold Medal.
- II. The Surajmani Saha Memorial Gold Medal for securing the highest marks in the subject of Taxation Law at the 4th Semester 3 Year LLB (Hons.) under CBCS shall be awarded.
- III. The Bijaya Memorial Gold Medal for securing the highest mark in the subject at Legal Theory (jurisprudence) at 1st Semester 3 year L.L.B. (Hons.) CBCS shall be awarded.
- IV. The Gourahari Panda Memorial Gold Medal for securing the highest mark in the code of Civil Procedure in the 4th Semester 3 year L.L. B. (Hons.) at M. S. Law College, Cuttack.
- V. Gold Medal for 3 year L. L. B. Examination shall henceforth be awarded only to CBCS L.L.B. (Hons.) students.

For II, III, IV and V the Gold Medal shall be awarded only on successful completion of the Course. This principle is applicable for all Gold Medals.

Hence, the Principals /Heads / Course Co-ordinators are requested to communicate the concerned eligible Candidates accordingly of your Colleges / Departments immediately for such award of the ensuing Annual Convocation of the University.

Further, this decision shall supersede all earlier orders and rules regarding the above rule and clarification.
