Your engagement is under the following terms and conditions:

- 1. The assignment is purely on a temporary basis initially for one year from the date of joining and may be extended/ renewed subject to the satisfactory performance report from time to time. Your engagement will continue, subject to approval from NCTE.
- 2. The Principal shall guide your work under the overall control of the Coordinator, UDTE and Chairman P.G. Council.
- 3. The emolument is Rs. 15,000/- (Rupces Fifteen thousand) only per month.
- 4. You will abide by the rules, regulations & discipline of the Utkal University.
- 5. The University Department of Teacher Education currently functions on the 2<sup>nd</sup> floor of Platinum Jubilee Building, DDCE Campus, Utkal University.
- 6. You will not be eligible for leave and vacation other than Casual Leave as admissible to the regular employees of the Institute/
  University.
- 7. In the event of leaving the position in between, you will be required to intimate the undersigned before 01(one) month or to deposit the emolument of one month. This may be relaxed if the candidates wish to join in any jobs of permanent nature.
- 8. University reserves the right to terminate you giving one month notice without citing any reason therof. On discipilanary ground, you may be terminated immediately.
- Joining will come into force with effect from the date on which you will report for duty at the University Department of Teacher Education.
- 10. If you will apply for any other jobs during your assignment, prior permission of Coordinator/ Chairman, P.G. Council is needed.

- 12. You are required to discharge any duty related to UDTE as and when required by the Principal, UDTE, Utkal University.
