

3. Your date of Registration is **13.02.2015**
4. However renewal of the registration will be required after completion of **five years** from the date of registration. The candidate can not avail annual renewal for more than three times.
5. You are required to submit your half yearly progress report on the research work through your supervisor.
6. You are required to make presentation at the end of 3rd year and 5th year after registration failing which your registration is liable to be cancelled.
7. The supervisor/ co-supervisor shall be mandatorily be present in all the presentations (Synopsis/ Renewal/ Pre-submission).
8. At least six months prior to the date of submission of the thesis you are required to inform the Controller of Examination through your supervisor in writing the date of submission of your thesis.
9. You can submit your Ph.D. thesis after completion of **2 years** from the date of Registration on presentation of pre-submission seminar and recommendation of SRC. Further you should have at least one publication based on the findings of the research. Such publication has to be after six months from the date of registration. In exceptional cases the Vice-Chancellor may be permit submission of thesis six months earlier. On production of three quality publication based on the Doctoral research work in referred /reputed journals.
10. In case of D.Sc./D.Litt. A candidate shall submit his/her thesis along with at least three new published papers relating to his/her topic of research, in reputed journals after registration. A certificate as regards reputed journals is given by the supervisor or the candidate in case of self guide.
11. You are required to submit the thesis within a period of **08 (Eight) years** from the date of registration failing which it will be treated as cancelled.
12. Your **B.C. /B.D. No. 307348** dated: **09.04.2015** for **Rs. 1500/-** as deposited vide **A.R. No. 126245** dated: **09.04.2015** is hereby acknowledged for issue of duplicate Registration number.


