Curricular Aspects

LOCAL, REGIONAL, NATIONAL AND GLOBAL RELEVANCE OF THE COURSES

The syllabi of all programmes cater to local, regional, national, and global needs and opportunities. **Although such distinction is largely overlapping** because what is important locally has regional implications and is also relevant at the national level. The courses are identified by the main objectives of the courses.

Here are some of the examples of courses:

I. Local relevance with a focus on Odisha.

In the Third Semester of M.A. Programme in History, the course HIST-C/AE/FE-11: Cultural Heritage of Odisha basically describes the importance of cultural heritage, its meaning as well as specification. Different types of heritage are included here to clear the understanding regarding of heritage. Buddhist stupas, chaityas as well as the sculpture of Jaina art is very prominent regarding culture of India. Apart from it religion is also included especially the regional development of different cults like Saiva and Vaishnava, yogini cult which is very important in Odisha region. Temple style as well as Jagannath cult is also dealt here including Mahima Dhama. In culture literature is also very important as well as festival, art and education.

In Special Paper: **Group-D, HIST-CE-13: History of Odisha** (Early Times to 1118 AD), the objective is to discuss the study of sources for the reconstruction of early Odisha history. The aim is to graph the historical geography of Ancient Odisha territories. It also explains Kalinga war and its socio cultural implications. The section also deals with the career and achievements of Kharavela and the contribution of other regional dynasties. This highlights the political administration, economy and cultural significance of Bhaumakaras and Somavamsis. The course highlights the geographical identity of ancient Odisha and the socio-cultural history of the time. It educates the students about the historical narration of Kalingan War and political atmosphere of the era of Kharavela. The Somavamsis and the Bhaumakaras also contributed to the administrative, economy and cultural significance.

In MBA in Rural Management **PAPER-17 RURAL TOURISM** the objective is to understand the concept of Rural Tourism- its scope and cultural significance. The unit 4 contains Sustainable Tourism, Agro Tourism, and Inspirational Tourism. Promotional Development provisions for rural tourism in **India and Odisha.**

II. Regional Relevance

In M.Sc. Anthropology, SEMESTER – IV, ANTH-CE-C4, PREHISTORY AND PROTOHISTORY OF EASTERN INDIA AND SOUTH EAST ASIA, the units pertain to Southeast Asia, Eastern India and Odisha for the study of prehistoric archaeology. So the Regional relevance is also taken care of in this course for example.

Moreover, ANTH-AE-1C / ANTH-FE-4: ARCHAEOLOGY OF ODISHA focuses on Odisha only.

III. National as well as Regional Relevance

While almost all M.A. Programmes in are in line with UGC Syllabus and national relevance, the project work, dissertation, internship opportunities in each programme for students address the local or regional concerns of the respective disciplines.

IV. International Relevance

The concepts included in all syllabi are taught with reference to current research studies in the world today. Research opportunities in most of the Programmes also take care of the global relevance through literature review.

Action taken: As per the suggestions of academic audit held from 16.3,2016 to 21.3. 2016 some of the action taken are: provision of ramp was made in departments wherever required; Alumni activities were recorded by departments; installation of CCTV; Renovation of museums; Provision for blended learning and revision of syllabus taking into accounts the inputs received from feedback of students, suggestions from faculty and Alumni.

In general, some of the good practices include

- Organization of student seminars on regular basis by most Departments
- Good seminar libraries
- Student managed library (in addition to seminar library) in some Departments
- Comprehensive vision and mission statement displayed
- Good museums as teaching-aid in various Departments like Anthropology, Ancient Indian History, Culture & Archaeology, Geology and Zoology
- Departments with Special Assistance Programme of UGC
- Rock Garden in Geology Department and herbarium in Botany Department

The Committee also took note that Department of Physics has been selected by the Ministry of Human Resource Development, Government of India as a Centre of Excellence.

The suggestions made during the visit are presented below:

- The need for recruitment of teachers is felt in almost every Department.
- Although a number of Departments and/or Societies associated with Departments are publishing journals, suggestions were made to enhance quality.
- In general, space crunch was felt because of the need for increasing lab space, ladies' common room and implementation of CBCS facilitating more options for students.
- Updating of alumni record and organization of alumni meet on regular basis was suggested.
- Mentoring of students and career counselling are to be strengthened.
- Consolidation of the list of placement is to be maintained.
- Departments like PMIR, Business Administration, Commerce, Computer Science and Chemistry are taking steps to have industry-academia interaction. This process has to be further strengthened.
- Steps taken for facilities for differently-abled people should be extended further.
- More interaction with parents and alumni should be held.
- In fieldwork and experiential study, students should be encouraged to undertake more projects with application value and of social concern.
- Students doing extension work should be encouraged and appreciated.
- Facilities for games and sports should be maintained, consolidated and improved.
- Departments have taken steps in sensitizing students regarding ragging as well as gender and social discrimination. In order to inculcate a spirit of inclusiveness among the students, such programmes should be organized at inter departmental level.
- Departments with Special Assistance Programme of UGC were instructed to prepare for Review by UGC as and when required

Departmental profile with regard to academics, teaching, research and other co-curricular activities were presented by concerned heads/ coordinators/ directors of departments. Following the presentation, the members of the committee interacted with the heads and faculty members.

Action taken: Based on the suggestion of Academic audit held on 15th, 16th, 17th April, and 28th May 2019, the following measures were taken by different Departments: Faculty profile updated on the university website; research scholars seminar held in different departments; students feedback collected and analysed; facility for common room for students made available; steps taken for inclusion of journals published by different departments in UGC approved journal list; Syllabi revised along with allied courses.

The progress in different academic activities of each department was evaluated and the salient features observed during the visit are presented below.

- 1. Mentorship for students is in practice in all the departments.
- 2. More than 50% of students receive scholarship in different departments.
- 3. It was proposed to develop a data base regarding the scholarship received by post graduate students of various departments.
- 4. Financial assistance for hands on training and study tour /field trip has to be enhanced to make the purpose more effective as the funds provided are not sufficient.
- Documentation of field trip was not properly recorded. So, all the departments are required to prepare documentation of field trips conducted.

- 6. In order to establish a viable link between the university and industries, departments like Chemistry, Biotechnology, MBA, PMIR, Geology, Geography and Pharmacy were advised to take appropriate steps like formation of MoU etc. Memorandum of Understanding (MOU) was proposed to be formalized to encourage collaboration with research institutes and industry.
- 7. Some departments like Anthropology, Computer Science, Commerce, History, Library and Information Science, Mathematics, PMIR and Sanskrit have no extramural projects at present. Faculty members were advised to apply for projects to create a better research environment in the respective departments.
- 8. Due to shortage of faculty, departmental research support (DRS, FIST etc.) to several departments have been stopped adversely affecting research activities of the department which was a matter of concern.
- 9. Consultancy provided to faculty members to various institutions was recorded. However, there was no financial benefit to the faculty members. It was decided to develop strategy towards encouraging faculty members to accept consultancy projects with financial gains. It was suggested to prepare guidelines to formalize and encourage consultancy projects to be taken up by faculty members.
- 10. Departments like Economics, History and Zoology have been publishing journals (Society/ departmental) which have been placed in the UGC CARE list. Other departments were advised to revive the journals published earlier and take required steps to include those journals into UGC approved list of journals. Journals published by all departments were asked to be displayed in the Parija library.
- 11. Alumni activities of all the departments were proposed to be recorded.
- 12. The proposal to open new courses such as Yoga and Data Science by the department of Sanskrit and Statistics respectively was a welcome move. Concerned heads were advised to develop the required syllabus and place it before the appropriate body for approval and subsequent implementation.
- 13. It came to the notice that in some departments students were publishing their research work individually without their guides as authors. It was proposed to discourage such unethical practices.
- 14. It was proposed to record achievement of students such as placement and awards by departments with proof.
- 15. Some of self the financing courses such as UDPS, Master of Journalism etc. face shortage of space. It was suggested to take appropriate steps to solve the problem.
- 16. It was suggested to start the process of clubbing together of similar self financing courses offered in different departments in consultation with concerned course coordinators. Since seats in Remote Sensing one year diploma course are laying vacant, it was proposed to replace the course by a two years degree course on remote sensing. Self financing departments were also advised to record faculty profile. Remuneration for classes was proposed to be standardised as per UGC guidelines.
- 17. It was suggested to upgrade the Rural Technology Park by the department of MBA (Agri Business).
- 18. Feedback from different stakeholders were discussed. Taking into account the impact of COVID-19, it was decided to be collect Student's feedback online. However students having no internet connectivity will submit the form offline as per the ongoing practice.

- . 19. Different clubs established by individual departments was proposed to be clubbed and activities to be performed at university level.
 - 20. All departments were requested to record activities of departmental alumni association.
 - 21. Course coordinator, Social Exclusion & inclusive policy was requested to prepare a report on "How has the centre empowered students".
 - 22. As an integral part of outreach programme, all science and social science departments were advised to take classes for the students of the University high school present in the Vani Vihar campus.
 - 23. Departments having museums and laboratories were advised to plan for regular visit of school students to their laboratories and museums to create awareness among children.
 - 24. Garbage disposal was a matter of concern in majority of the departments. It was decided to take appropriate steps for clearance of garbage by constituting a committee.
 - 25. Recruitment of faculty members in most of the departments and appointment of Laboratory Assistant/ Technical Assistant in all science departments was a matter of great concern in order to maintain quality education in the University.

Action taken: The following activities discussed during the Academic Audit 2019-20 were adapted /in progress by different Departments.

- 2. Mentorship for students is in practice in all the Departments.
- 3. Viable link between the university and industries/ research institutions have been established. Memorandum of Understanding (MoU) to encourage collaboration with research/Academic institutes and industry has been initiated.
- 4. Consultancy with financial benefit was initiated by the department of Business Administration and Agri-business.
- 5. Initiatives taken to display Journals published by different Departments of the University in the Parija library / Website.

- 6. Alumni activities of all the departments were recorded.
- Achievement of students, such as placement, fellowships and awards has been recorded by departments along with necessary proof.
- New programmes on Human Consciousness and Yogic Science and Data Science have been started by department of Sanskrit and Statistics, respectively with approved syllabi.
- One year diploma programme in Remote Sensing has been replaced with two years Geo-Informatics.
- 10. M.Sc. Computer Science programme offered by the Department of Mathematics and Department of Computer Science and Applications were clubbed to one self-financing programme.
- 11. Faculty profiles of self-Financing programmes were recorded and steps taken towards payment of remuneration for classes as per UGC guidelines.
- 12. Rural Technology Park was upgraded by the Department of MBA (Agri Business).
- 13. Student's feedback forms were collected online.
- 14. As an integral part of outreach programme, several Departments interacted with and took classes of the students of the University high school present in the Vani Vihar campus.

- Evaluation of learning level of students, mode of evaluation and remedial measures taken were presented by Departments.
- 7. Status of Mentor-Mentee and action taken was recorded.
- 8. Presentation of action taken report based on the feedback (Student/Alumni/Parents).
- E-content (Study materials) developed by the Faculty members and uploading the same on University Website in the form of pdf and video.
- 10. Award and recognition received by the faculty members and uploading the same on University website.

- 11. Information related to Extramural Research Projects received from Govt. and non Govt. organizations, Consultancy Projects, and organizations of International and National seminars / workshop (online/off line or blended mode)
- 12. Publications by faculty members (Research articles, Books, Book Chapters and Conference proceedings)
- 13. Achievement of research scholars and students (NET/GATE etc.; Awards; Placement and others)
- 14. Outreach programmes conducted and Best practices adopted by the Departments were discussed.
- 15. Disposal of wastes to be taken up on priority basis. It was suggested to constitute a committee or the same.
- 16. Authority to take appropriate measures immediately for recruitment/engagement of Laboratory Assistant/ Technical Assistant in all science departments having practicals for smooth running of the class.
