## BROAD GUIDELINE FOR CONDUCT OF ENTRANCE TEST FOR ADMISSION TO PH.D PROGRAMME 2022-23.

With approval of the appropriate authority following are the broad guidelines for conduct of Ph.D Entrance Examination and admission to Ph.D course work for the session 2022-23.

- 1. Ph.D Entrance examination for admission to Ph.D programme (written & viva-voice test) will be conducted under the supervision of HODs/Coordinators of Nodal Center of concerned Department/ Subjects(Except Ayurveda and Physical education which will be conducted at UDTE. However the Viva-voice test of these candidates will be conducted the concerned nodal center).
- 2. All Questions will be of objective type with 04 multiple choices and there will be no negative marking. Questions will be of (70 questions with 1 ½ hour duration) with OMR based answer. A scholar who is not exempted from written test will have to appear at the Entrance Test in two sittings(1<sup>st</sup> sitting on Research Methodology and 2<sup>nd</sup> sitting on Subject Domain).
- 3. Candidates appearing in more than one subject will appear in Research Methodology in parent department(as per P.G. subject). The marks secured in this paper will be taken into consideration for all other subjects they have applied for.
- 4. Entrance test is to be held in different departments on 30<sup>th</sup> November in 3 sittings as per programme notified.

- 5. A) Result of the written test to be published on 7<sup>th</sup> December.
  - B) Viva-voice test to be completed by 20<sup>th</sup> December.
  - C) Publication of Final Merit list by different by departments/Nodal Centers by 24<sup>th</sup> December.
  - D) Admission to be completed by 30<sup>th</sup> December.

- 7. Course Fee for admission into Ph.D Course work Rs.10,000/-.(Department share Rs.8000/- and P.G. council office Share Rs.2000/-)
- 8. Commencement of Ph.D Course Work 1<sup>St</sup> January,2023.
- 9. Completion of Course Work-30<sup>th</sup> June,2023.
- 10. Examination & publication of result of Ph.D Course Work to be completed by 15<sup>th</sup> August, 2023.
- 11. The Ph.D programme, being regular in nature, a scholar after registration has to complete 2 years residential period including the period of course work.
- 12. Scholar with M.Phil degree with NET/ JRF are exempted from Written test, however they are required to complete the course work.
- 13. Those who have cleared NET/ JRF after last date of application but before the date of written test they are exempted to written test. Document in support of NET be submitted to the respective Department and NIC helpline mail ID.
- 14. Hard copy of the application form be deposited to the HOD of concerned Department or Co-ordinator of the Nodal centre.
