

- All the scholar irrespective of department, whose date of registration to Ph.D. programme is on or after 18th February, 2018 have to deposit a mandatory processing fee of Rs. 500/- in shape of Bank Draft drawn in favour of comptroller of Finance, Utkal University, at the time of submission of half yearly progress report to Controller of Examinations duly certified by supervisor and forwarded by chairperson, DRC (Departmental Research Committee).

As a regular Ph.D. student you have a mandatory of 2 (two) years of residency period in the place of research.

- The candidate shall present the pre-submission seminar before the DRC (Departmental Research Committee) at least two months before the final submission. The feedback and comments obtained from DRC (Departmental Research Committee) may be suitable incorporated into the draft thesis. The period between the date of pre-submission seminar and date of final submission of thesis shall not be more than three months.
- The candidate is required to give in writing through supervisor to the office of the Controller of Examinations at least Six month before the date of Ph.D. Thesis submission.

10. Any suppression of facts or contravention to rule liable to cancellation of your registration.
