I am directed to inform you that it has been decided to constitute a team of Inspectors where you are a member for conducting local inspection in order to ensure as to whether adequacy of facilities are expressly available in the said college for grant of Provisional affiliation as stated below.

1. Grant of Provisional affiliation in **B.Sc (Nursing) Programme with 60 seats (INC-40 & ONMC-60 seats) for the session 2020-21, & B.Sc Nursing Programme with 60 seats (INC-40 & ONMC-60 seats) for the session 2021-22.** The State Govt. approval provisional recognition has been granted by ONMC in Nursing course with obtain seats has been reduced by the INC in Nursing course seats as per W.PC No. 5030/2019, & in IA No.4620 of 2019, by virtue order passed by the Hon'ble High court of Odisha dated 20.8.2019 order no-15 that the state Govt. allotment will prevail over the Central Govt. INC allotment, pass out students of concered institutions will not be recognised by the Govt. of India (INC) shall be entitled registration in the State of Odisha only. If the students admitted in Nursing/ other course beyond the intake capacity of INC/DCI/Govt. of India, the University will not be held responsible beyond the admission capacity.
2. Grant of 1st Provisional affiliation in **P.B.B.Sc. Nursing Programme with 50 seats (ONMRC) approval for the session 2020-21 & its extension of Provisional affiliation in P. B.B.Sc (Nursing) Programme with 50 seats (ONMRC) approval for the session 2021-22.** (As per clause 173 of OUFS 1990 non submission of obtaining approval, recognition, permission from the All India body or the Council, Nursing Council of India (INC) shall be entitled to be recognised only in the state which the institution situated & passing out students registration in the state of Odisha only), (as per WP (C) No.5030/2019 & order No.15, Dt.20.8.2019) ('The Secretary, INC issued letter vide No.28.02.2019-INC dated 9.12.2020, clarified that the power to grant recognition to Nursing Institutions vests with state Nursing Council, the Hon'ble High court of karnataka in WP(C) No.25355 and 25357/2017 vide Judgement dated 24.07.2017 had held, It is declare that the Indian Nursing Council, herein has no authority to grant recognition to the Institutions imparting Nursing Courses".)

For this a copy of Proforma for local enquiry and copy of statutory condition are sent to the Principal/Director, College concerned and to ensure that all the conditions of the statutes and Govt. concurrence are fulfilled by the college. You will be paid remuneration of Rs.500/- only by the institution & it will arrange transport for your to and fro journey.
