1. Adequate number of faculty with PhD may be appointer on regular basis as per UGC regulation 2018.
2. Adequate number of text/reference books, as per PG Syllabus, may be procured on urgent basis. At least eight number of International/national journals each in Physics and Odia may be subscribed immediately.
3. Sufficient number of experimental laboratory may be set up for smooth conduct of PG Physics practical.
4. The college should take immediate step to form its Governing Body.
5. The Cash Book, DCR and other financial records may be maintained by efficient persons those who have Knowledge about financial rules.
6. Reservation rules of Government of Odisha may be followed in the PG the PG admission.
7. Separate UG and PG time tables and Teacher Council Resolutions must be prepared and maintained as per rule.
8. Failing to satisfy the above recommendations, the admission for the next academic session and onwards may be stopped for both the programs.
