Nursing Programme with 20 seats (INC-20 seats approved)** for the session 2020-21 & 39 seats (ONMRC-40 seats approved) & (INC-20 seats approved) for the session 2021-22 is granted to **Sabarmati College Of Nursing, Mahanadi Vihar, Cuttack-753004**, subject to fulfillment of the following conditions.
