It is notified for information of all concerned that as per the recommendation of the Affiliation Committee Meeting held on 7.06.2023 and subsequent approval of the Syndicate dated 07.07.2023, the Provisional affiliation in B.Sc. Nursing Programme with 33 seats (ONMRC approval) for the session 2021-22 (As per clause 173 of OUFs 1990 non submission of obtaining approval, recognition, permission from the All India body or the Council, Nursing Council of India (INC) shall be entitled to be recognised only in the state which the institution situated & passing out students registration in the state of Odisha only) is granted to Ganesh Institute of Health Science, Plot No-670, Sunguda, Chandikhole, Jajpur-754296 subject to fulfillment of the following conditions.

1. The LEC member could not meet the Principal of the college on the day of visit even though the visiting date was pre-specified in consultation with the college representatives.
2. As per the record submitted by the college (Annexure-12), T.R. Thipeeswamy was the Principal during the session 2021-22, but the signature of the Principal is different in different documents.
3. The Principal has no valid ONMRC registration number.
4. The faculties are not properly qualified. The experience shown is not correct.
5. Personal records of the faculties are not properly maintained and also no supporting documents for the experience of faculties are available.
6. The library has very few books and no accession/issue letter in available in the library. There was no Journals/news paper available in the library.
7. The spaces available for different laboratories are very small in size.
8. No separate cash book is available for the college.

The compliance report regarding fulfillment of the conditions should be complied within six months from the date of issue of this notification, failing which the College shall stand disaffiliated as per Status 198 of O.U.F.S 1990 without information.
