2. Four self attested copies of (02) stamp size & (02) passport size of your recent photograph.
3. Mark-sheets in original of all examinations passed beginning with matriculation of HSC.
4. Matriculation / HSC / SSLC in original.
5. Original / Provisional certificates of all University examinations passed.
6. Migration certificate (in case of students coming from other Universities) in original. If not submitted at the time of admission, migration certificate be submitted within two months.
7. Registration receipt of the Utkal University in original.
8. Proof of qualifying UGC-CSIR-NET/GATE/SLET/INSPIRE Fellowship of DST and Awardees of Teacher Fellow, completion of M.Phil. degree with admission through entrance for entrance exempted category candidates
9. Caste certificates in original, if any
10. Relieving order from the competent authority in case of employee.
11. An undertaking by non-employed candidates to the effect that he/she not employed.

Any misinformation found on verification of the original documents and detected afterwards shall lead to cancellation of selection / admission and will be treated as a cognizable offence.




