# **About the Department**

The birth of Analytical and Applied Economics department took place in the name of Department of Rural Economics and Sociology in the year 1956 with an initial grant from the Ford Foundation. The postgraduate teaching in Applied Economics was introduced in the department in 1963 and in 1974 the name of the department was changed to the Department of Analytical and Applied Economics.

In recognition of the significant contributions made by this department in the field of economics research, the UGC selected the department as a Centre for Teacher-Fellowship Program in Economics in 1977, as a Department of Special Assistance (DSA) in 1989 and Centre of Advanced Study (CAS) in 2010-11. The Department has also been recognized by the UGC under the ASIHSS program for a period of five years from 2006-07 to 2011-12. The academic and research contribution of the department was also recognized by the SBI and it instituted a Chair in Rural Economics with an Endowment of Rs.6 lakh in 1981, which functioned till 2000. The RBI also instituted a Chair in Institutional Finance in 1982, which is now functioning with an enhanced corpus of Rs.10 crore.

The department now offers MA and PhD courses in Analytical and Applied Economics. The faculty members of the department have won several national and international fellowships, awards and other grants from time to time. Almost every year, the department has organised various regional and national seminars and workshops. The department brought out a journal entitled "Utkal Economic Papers" (ISSN 0976 – 7592) to promote the publication of original research works carried out by the faculty members of the department and several affiliated colleges in Orissa.

### Theme of the Conference

The broad theme chosen for this year's conference is "Institutional Finance and **Economic Development".** The theme is extremely relevant in the current context as India's financial system has become vibrant. The intermediation process is no longer limited to commercial banks. The whole host of financial institutions are currently catering needs non-bank the ofnon-financial companies/government(s). Direct financing through the capital market is growing rapidly. Derivative instruments provide avenues for risk management. Digitisation is progressing well. Insurance and provident funds are also playing their role in long-term financing. The financial markets have acquired sophistication through innovative products.

A complex financial system not only offers multiple opportunities for financing economic development but also throws several challenges like financial instability, asset quality management, resolution mechanisms, and risk management. The sub-themes are proposed keeping in view the growing needs of the economy. Research output on the sub-themes within the overall theme would be most useful for policy purposes besides giving good exposure to participating students/scholars/faculties in a niche area of applied economics.

# **Guidelines to Participants/Authors**

- The conference is open to students/scholars/faculties/professionals in the fields of economics, commerce, finance and management.
- The participants interested in presenting papers must submit the full paper including a one-page abstract of the paper (not more than 300 words) within the deadline. The abstract must contain the title of the paper, author's name(s), affiliation(s), full postal address, email ID, phone number(s) and disclaimers/acknowledgements, if any.
- Full text of the paper must be sent by email to rbiprof.uu@utkaluniversity.ac.in, typed in MS Word, Times New Roman, font size 12, 1.5 space (word limit 6000).
- The paper should be original, empirical and unpublished. Review articles shall be considered in exceptional cases.
- An internal Editorial Committee shall scrutinize the papers. Acceptance/rejection of the paper shall be notified to the author(s) by email. If a good number of quality papers are received, an edited volume shall be published subject to peer review.
- The author(s) of accepted papers will have to present their paper preferably through powerpoint slides within 10-15 minutes. The powerpoint slides of the paper should reach the Chief Organiser on or before 28 February 2024 by email given above.

# Registration

Registration is compulsory for all delegates. The attached registration form duly filled in should be sent to the Chief Organiser by email.
