Peer Review:

This journal employs a double anonymized review process. Initially, the editor evaluates all submissions for suitability. Papers deemed appropriate are then typically sent to a minimum of two independent expert reviewers for assessment of their scientific quality. The final decision regarding acceptance or rejection rests with the Editor, whose decision is considered conclusive.

Editors abstain from involvement in decisions concerning papers authored by themselves, family members, or colleagues, or those related to products or services in which they have a vested interest. Such submissions undergo the standard peer review process, with evaluations conducted independently of the relevant editor and their research groups.

Guidelines for Authors:

- All manuscripts must be submitted through the Research in any aspect of Odishan, Indian, and South Asian History.
- Manuscripts and editorial correspondence should be addressed to **jayantidora69@gmail[dot]com**
- Create your research paper with sections like abstract, introduction, related research work, research methods you used, conclusion, references etc. and format it according to our journal's recommended format.
- All articles must be printed on one side of A4 paper with margins on all sides and double spaced throughout (i.e., including quotations, notes, references and any other matter).
- Authors are requested to provide two hard copies and an identical electronic copy as an e-mail attachment. Manuscripts should be in **MS Word format**. Contributions in **PDF format will not be accepted**.
- All articles must contain 4000-6000 words: include 4–6 keywords : an abstract of about 200 words : and carry contributors's affiliation(s), mobile number, complete postal and e-mail addresses. Any paper excluding the range will not be eligible for the inclusion.
- A complete list of all references cited in the article, including any tables, graphs and maps, should be provided. **Do not distinguish between Primary and Secondary references; they must all be included in one alphabetical list.**

- **Format:** Font-Times New Roman, Title Font Size- Times New Roman size 14 (CAPITAL), Text Font Size-12,Space-1, Pagination in Numerals, Footnote/Endnote-Continuous Footnote- Times New Roman size 10; References-At the end of in the format given below.

Plagiarism policy: Every paper should accompany a similarity index report in Turnitin plagiarism software. The plagiarism percentage should not exceed 10% (excluding 8 words). Further it should not be more than one per cent from one source.
