It is notified for information of all concerned that as per the recommendation of the Affiliation Committee Meeting held on 21.11.2023 and subsequent approval of the Syndicate dated 16.12.2023, the Provisional affiliation in M.Com (F&C) Programme with (i) 03 seats for the session 2018-19, (ii) 04 seats for the session 2019-20 and (iii) 09 seats for the session 2020-21 respectively is granted to Com Point Institute of Information Technology, 242, Biswalpada, Khandeita, Cuttack-753011 subject to fulfillment of the following conditions.

- An Adequate number of faculty with PhD may be appointed on a regular basis as per UGC Regulation 2018.
- 2. Library Infrastructure may be developed and an adequate number of text/reference books, as per the Syllabus, may be procured on an urgent basis. At least eight International/national journals in Commerce may be subscribed to immediately.
- 3. The college should take immediate steps to form its Governing Body.
- 4. The Budget/Annual Financial Statement of the College, Cash Book, DCR, and Cash Receipt Book must be prepared and maintained as per rule immediately by an experienced accountant.
- 5. Timetable and Teacher Council Resolutions must be prepared and maintained as per rule.
- 6. As there are no COVID-19 norms now, classes should run in physical mode.
- 7. The computer lab, washroom/toilet/lavatory should be immediately recovated and make functional.
- 8. The admission register should be maintained as per the rule.
- 9. Failing to satisfy the above recommendation, admission for the next academic session and onwards may be stopped for the program.
- 10. More number of regular teachers are to be appointed;
- 11. Separate reading room for students and library is to be setup;
- 12. Regular seminar and guest lecturer sessions are to be organized;
- 13. The number quality of Journal in the field of Management and Commerce are to be increased;
- 14. Needs strengthening library and computer facility.

The compliance report regarding fulfillment of the conditions should be complied within six months from the date of issue of this notification, failing which the College shall stand disaffiliated as per Status 198 of O.U.F.S 1990 without information.
