It is notified for information of all concerned that as per the approval of the Syndicate meeting held on 16.12.2023, the Vice-Chancellor has been pleased to grant of 1st & extension of Provisional affiliation (under Clause 6(15) on 4.4.2024, which is to be rectified in the Syndicate) in

(1) Post Basic B.Sc. Nursing programme with 14 seats as per admission (out of INC approved 20 seats) & (out of ONMRC approved 20 seats) for the session 2018-19; 49 seats as per admission (out of ONMRC approved 50 seats) & (INC approved 20 seats) for the session 2019-20; 35 seats as per admission (out of ONMRC approved 50 seats) & (INC approved 40 seats) for the session 2020-21 & 35 seats as per admission (out of ONMRC approved 50 seats) & (INC approved 40 seats) for the session 2021-22. (As per W.PC No. 5030/2019, & in IA No.4620 of 2019, by virtue order passed by the Hon'ble High court of Odisha dated 20.8.2019, that the state Govt. allotment will prevail over the Central Govt. INC allotment, pass out students of concerned institutions will not be recognised by the Govt. of India (INC) shall be entitled registration in the State of Odisha only. If the students admitted in Nursing/ other course beyond the intake capacity of INC/DCI/Govt. of India, the University will not be held responsible beyond the admission capacity).

(2) B.Sc. Nursing Programme with 30 seats (INC approved 30 seats) for the session 2017-18; 24 seats as per admission (out of INC/ONMRC approved 30 seats) for the session 2018-19; 40 seats (INC approved 40 seats) for the session 2019-20; 40 seats (INC approved) for the session 2020-21 & 39 seats (out of INC/ONMRC approved 40 seats) for the session 2021-22.


(3) M.Sc Nursing Programme with 03 seats (out of ONMRC approved 40 seats) for the session 2020-21; & 14 seats (out of ONMRC approved 40 seats) for the session 2021-22, (As per clause 173 of OUFs 1990 non submission of obtaining approval, recognition, permission from the All India body or the Council, Nursing Council of India (INC) shall be entitled to be recognised only in the state which the institution situated & passing out students registration in the state of Odisha only) to **Dibya College Of Nursing, At/Po-Angul, Odisha- 759122**, subject to fulfillment of the following conditions.

1. The existing infrastructure needs to be developed as it is inadequate as per INC norms.
2. The Institution needs to procure more number of text books with latest edition.
3. The Laboratory should be well equipped to meet the requirements of the students.
4. The Accounts Books /Cash Books are not maintained properly and, therefore, immediate attention is necessary in this respect.
5. The authority should take appropriate steps for installation of fire extinguishers to meet the exigencies.




