It is notified for information of all concerned that as per the approval of the Syndicate meeting held on 16.12.2023, the Vice-Chancellor has been pleased to grant of **1st Provisional affiliation** (under Clause 6(15) on 25.4.2024, which is to be rectified in the Syndicate) **in B.Sc. Nursing Programme with 60 seats (ONMRC approval) for the session 2020-21 & its extension of Provisional affiliation in B.Sc (Nursing) Programme with 60 seats each (ONMRC approval) for the session 2021-22 & 2022-23** (As per clause 173 of OUFs 1990 non submission of obtaining approval, recognition, permission from the All India body or the Council, Nursing Council of India (INC) shall be entitled to be recognised only in the state which the institution situated & passing out students registration in the state of Odisha only) to **SOS College of Nursing, At- Bagada, P.S-Kendrapara, Pin-754211**, subject to fulfillment of the following conditions.

1. SOS College of Nursing, Kendrapara functioning in rented building;
2. The Size of classroom, library & laboratories are inadequate and not in conformity with INC norms.
3. Library books, Journals & laboratory articles are inadequate;
4. Fire safety certificate could not be provided, however, an undertaking has been provided by the institution.
5. Institution has not obtained INC approval under sec 13 & 14 of INC Act 1947.
6. Principal was not present during local enquiry.
7. Faculty members are less experienced.
8. Faculty members have not updated their status in Nurses Registration Tracking System (NRTS) as per INC guidelines.
9. The SOS College of Nursing, Kendrapara is not suitable for nursing affiliation.
