Applications are invited from interested retired University employees/ retired State Government employees for re-engagement in the post of Physical Education Officer and Jr.Stenographer on contractual basis as per the following terms and conditions:

1. The post is purely temporary in nature.
2. The selection will be governed by the procedure and rules laid down in the GA department resolution no.23750/Gen Dtd.27.05.2014.
3. The monthly remuneration will be fixed as per Finance Department Office memorandum no.24533/F dtd.29.09.2022.

Eligibility Conditions:

1. (i) The retired persons who have retired from University/ Govt. Service on attaining the age of superannuation and below the age of 63 years having good service records and are physically fit shall be eligible to be considered for re-engagement.
(ii) The retired employees against whom departmental proceedings or criminal cases are contemplated/ pending or who have been penalized for misconduct during the period of five years preceding the retirement may not apply.
2. The engagement will be initially made for a period of six months which may be extended by further period of six months subject to satisfactory performance up to a total period of three years not beyond the age of sixty five years of age in any case or till the posts are filled up by regular process whichever is earlier. The competent authority reserves the right to terminate the engagement at any time by giving one month written notice to the appointee. On the contrary, if any re-employed employee desire to resign, he/she shall do so by giving one month's written notice to the competent authority.
3. The period of engagement shall not be counted as University service/ Govt. Service for the purpose of pension and any other retirement benefits and the engaged employees will be subject to and will abide by the provisions of Odisha Government Servants Conduct Rules, 1957 and shall be liable to be proceeded against for their misconduct, omissions and commissions as per the provisions under the Odisha Pension Rules,1992.

The last date of receipt of application is 16.08.2024 by 5.00 P.M. The application is to be addressed to the Registrar, Utkal University, Vani Vihar, Bhubaneswar-751004 by Registered post/ Speed post. Selection will be finalized by the selection committee constituted for the purpose. The services can be terminated by the authority at any time without assigning any reason thereof. Further, the University reserves the right to cancel the selection process without assigning any reason thereof.
