Guidelines for engagement of RBI Chair Professor

1. Genesis of RBI Chair

The Reserve Bank of India (RBI) has instituted a Professorial Chair and fellowships in Utkal University under the scheme of Endowment of Professorial Chairs and Fellowships in Universities and Research Institutions and other Grants for Promotion of Research, Training in Banking and Economics for research in economics and allied subjects at higher levels of learning.

The University engaged a Chair Professor to undertake research/training activities in relevant areas, the expenses of which including the emoluments of the Chair Professor were met from the income earning of the corpus fund. The emoluments of the supporting staff/research fellows, travel, stationery, computer usage, etc. were also met from the income earning of the corpus fund.

Thrust Areas of Research will revolve around but not limited to

- a) Institutional Finance
- b) Financial Capability
- c) Economics of Social Sector (including Health and Education)
- d) Green Financing
- e) Rural Financing

- i. Number of Position: 01 (one)
- ii. Mode of selection: Through open advertisement
- iii. Nature of engagement: Temporary
- iv. Level: Professor
- v. Remuneration: As per UGC Guidelines / Rules
- vi. Duration: Ordinarily for 2 (two) years, extendable to one more year subject to annual performance review by the University Authority.
- vii. Since the post is for a limited tenure, the selected candidate shall be required to furnish an undertaking to the effect that she/he will not claim any regularization of the engagement.
- viii. Maximum age limit to apply for the post: 62 years

ix. Educational Qualifications and experiences required

An eminent scholar having a Ph.D. degree in the concerned/allied/relevant discipline and published work of high quality, actively engaged in research with evidence of published work with, a minimum of 10 research publications in peer-reviewed journals of international repute and a total research score (API) of 120 as per the criteria given in of University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018 of 18 July 2018.

OR

An outstanding professional, having a Ph.D. degree in the relevant/allied/applied disciplines, from any academic institution/ industry, who has made a significant contribution to the knowledge in the concerned/allied/relevant discipline, supported by documentary evidence provided he/she has ten years' experience.

OR

In the event the candidate is from Industry and the profession, the following shall constitute as essential:

- a. Consistently good academic record with at least 60% marks in Master's Degree in a relevant/ allied/concerned discipline or equivalent.
- b. An outstanding professional with an established reputation in the relevant field, who has made significant contributions to the knowledge and practice in the concerned/allied/relevant discipline, to be substantiated by credentials.
- c. The candidate should have significant professional work experience that can be recognized at the national/international level as equivalent to a Ph.D. and 12 years relevant/allied experience in industry/profession.
- x. The candidate is requested to submit a pre-proposal regarding her / his research plan during the tenure of the chair.

xi. Scope of Research:

- a. Conducting research (doctoral/empirical) as per the mandate of the research chair.
- b. Publishing research articles in national and international journals.
- c. Developing courses and their curriculum for undergraduate and/or post-graduate students in the specialized area.
- d. Conduct training and capacity-building programs.
- e. Identify and disseminate best practices in the identified field.

- f. To publish in the form of books, and monographs, to meet the existing knowledge gap and the results of studies conducted by the chair.
- g. Sponsor/organize seminars /workshops/conferences etc. on the issues relating to the scope of the research chair.
- h. Any other topic/thematic area proposed by RBI / Utkal University as per requirement.
- xii. Duties and Responsibilities: The Chair shall be located in the Department of Analytical & Applied Economics. Chair Professor shall perform all Academic, Research, and administrative functions as decided by Utkal University in consultation with RBI. Duties and responsibilities shall, inter-alia, include:

Academic and Research Functions:

- a. To pursue high-quality research in the identified thrust areas with a clear focus on "Institutional Finance" and allied subjects that complement existing activities that will generate impact.
- b. To engage in policy research with a clear view to meaningfully add policy options for policymakers.
- c. To publish high-quality research output in the forms of books, monographs, working papers, articles, and reviews in international peer-reviewed academic journals and other appropriate forums
- d. To participate in teaching (PG, M.Phil.) and take part in Ph.D. Program.
- e. To contribute to the vibrancy of the research culture of the University.
- xiii. Outline, schedule, and final outputs for the tasks: The Chair Professor shall, within 45 days of his/her joining, develop and submit a work program for the next 12 months of the Research Chair to RBI and University approval authority. A broad framework of activities for the complete duration of the Research Chair shall also be prepared.

xiv. Deliverables:

- Organizing one international and one national Conference/Seminar followed by Publications in her/his tenure.
- At least one publication in Scopus/WoS indexed Academic Journals of International repute in an academic year (at least three publications in Scopus/WoS indexed journals in her/his tenure)
- Organizing at least one RBI distinguished public lecture by invited speakers / by the Chair Professor in an academic year (at least three distinguished lectures in her/his tenure)
