1. The Chemistry laboratory facilities are highly inadequate for M.Sc. course. College needs to take immediate steps to purchase chemicals and other laboratory items to run practical class effectively.
2. The Geology and Computer Science laboratories are also in bad shape and head up gradation for running practical class.
3. The College is required to submit yearly report on development of laboratories to the Director, CDC, Utkal University till next visit of LEC.

The compliance report regarding fulfillment of the conditions should be complied within six months from the date of issue of this notification, failing which the College shall stand disaffiliated as per Statute 198 of O.U.F.S 1990 without information.
