Call for Papers

Human history has entered a phase where the long-cherished ideals of liberty, equality, and fraternity appear increasingly difficult to realize. In his book *Rethinking Democracy* (2005) Rajni Kothari holds that these democratic values and the idea of a state are worth pursuing so as to liberate people from the shackles of both traditions and modernity. These ideals and values together provide humankind with a vision of a utopian social order----humane and just. For long it has been imagined that a "democratic way of life" will provide humanity with the necessary framework of, both institutional and ideological, through which the utopia could be realized. It is against this backdrop that the faith in such an ideological cum institutional framework for 'delivering the goods' is being questioned. Unprecedented challenges and political upheavals in different parts of the country and the world offers the opportunity for reevaluating and rethinking democracy.

Democracy has never been more contested. For those who have it, democracy offers a grabbag of rights and freedoms not found in other regime types; for those who want it, democracy holds the promise of a better life free from the constraints of oppressive forms of power. Democracies around the world are being weakened from within—by the actions and efforts of their elected leaders. In their book, Dr. Erica Frantz, Dr. Andrea Kendall-Taylor, and Dr. Joseph Wright(2023) discuss how the rise of personalism in democratic politics has become the key culprit for democracy's ills. Personalist leaders—or those leaders that take on outsized influence relative to the parties that back them—are more likely to dismantle institutional checks on the executive, deepen political polarization, and weaken supporters' commitment to democratic norms of behavior, all actions that pave the way for democratic backsliding and collapse.

India too, is undergoing massive process of inner change. It may be highlighted here that India was one of the first countries to embrace democracy as its mode of self-rule following decolonization. The most important questions and apprehensions at the inaugural moment of India democracy were pertaining to the possibility of democratic political system in a deeply hierarchical society and forming deliberative reasoning in order to arrive at substantive and enduring agreements amidst the enormous diversity and inequalities prevalent in India.

The challenges contemporary India faces are – how to relate and join the deeper ie the inner drives of citizens and communities to the broader challenges of socio-political transformations and the still larger challenges of emancipation; how to engage in the preservation of freedom and autonomy in the face of external confrontations of both corporate and transnational varieties, and confrontations from within the nation state, such as economic divides based on caste and class, and the more threatening communal, religious and ethnic identities of communities. D. L. Seth (2018) rightly maintains that the base of institutional democracy in India will have to expand beyond parties and elections and the political authority will have to seek legitimization by also responding to the politics of no-party and non-electoral organizations and movements that have arisen in the wider public realm.

It is therefore, important to explore the challenges that confront this indeterminate form of governance. The seminar gives the opportunity to explore the nature, and contemporary practice of democracy – both in India and elsewhere across the globe. It is an attempt to provide alternative narratives about the complex and contested history of democracy and also to highlight on the nature and functioning of democratic political institutions including the rise of non-democratic powers, while examining the future of democracy
