1. 1st Provisional affiliation in BBA programme with 02 seats (as per admission) for the session 2018-19 & extension of Provisional affiliation with 02 seats (as per admission) for the sessions 2019-20 with 23 seats (as per admission) for the session 2020-21; with 15 seats (as per admission) for the session 2021-22 (out of approved seats strength of 32 for each session) & with 16 seats (as per admission) for the session 2023-24 (out of approved seats strength of 64). Further mentioned that there was no admission in BBA programme in the academic session 2022-23.
2. 1st Provisional affiliation in BCA programme with 24 seats (as per admission) for the session 2018-19 and extension of Provisional affiliation with 27 seats (as per admission) for the session 2019-20 with 19 seats (as per admission) for the session 2020-21 with 28 seats (as per admission) for the session 2021-22 with 28 seats (as per admission) for the session 2022-23 (out of approved seats strength of 32 for each session) and with 64 seats for the session 2023-24 (Out of approved seats strength of 64) to **Gandhi National College, Badaraghunathpur, Madanpur, Bhubaneswar-752054**, which is subsequently to be ratified by the Syndicate at its next meeting subject to fulfillment of the following conditions.
